- 5. The tender is based on **TWO COVER System**
- 6. Contractors should have registration in BWSSB or KPWD/KUWSDB, etc as per KTPP norms. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order
- 7. The last date for uploading of completed tender document is **on 26.09.2022** upto **15:00 hrs.** The bids will be opened at the office mentioned in para no.12 on **28.09.2022** after **17:00 hrs** in the presence of bidders or their authorized representatives. If the bid opening day remains as public holiday, Bids will be opened on the next working day at the original stipulated time.

Each tenderer should further demonstrate (a) availability by owing at least 50% of the required/specified key & critical equipment for this work and (b) the remaining 50% can be deployed on lease / hire basis for all works provided, the relevant documents (commitment agreements etc.,) for availability for this work are to be furnished.
- 13. Amount put to tender is **exclusive of GST.** The GST will be reimbursed at the prevailing rates as applicable.
- 14. Applications / requisitions from joint venture Firms are not acceptable
- 15. The Thirty party Agency inspection will be carried out and the Thirty party Agency will be nominated by BWSSB only.
