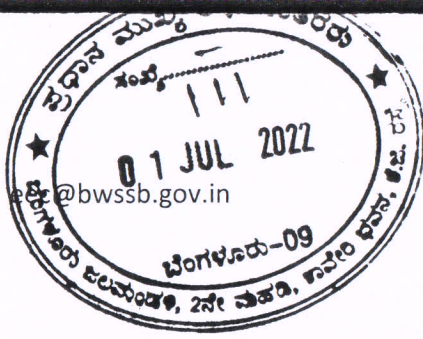

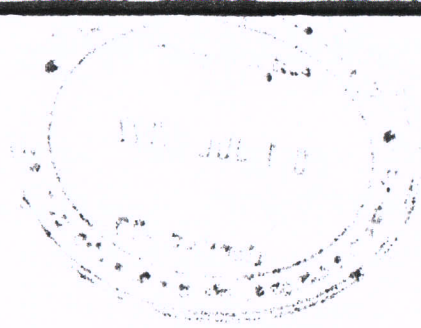

Tenders will be opened on the date and time mentioned in ITT clause 5 and evaluated. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.




The Eligibility criterion for the above works is as follows:

- The tender is based on Single Cover System
- Contractors should have Civil Contractor registration in BWSSB or KPWD/KUWSDB etc., Those who does not have BWSSB registration can also participate in the tender provided they should get registered in Board in case the tender is awarded before the issue of Work Order.
- Assessed Available Tender Capacity ($A * N * 2.5 - B$).
- Form of tender is mandatory to upload in e-procurement portal.
- Security Deposit for an amount equivalent to 5% of the contract price shall be deducted in every running bill. However, in case of First and final bill the entire security deposit will be deducted from the bill and for unbalanced tenders additional security deposit.
- Applications / requisitions from joint venture Firms are not acceptable.
- Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
