

For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWISE TENDER** is invited through e-procurement process with tender procedure online with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary North Division, Pinakini Bhavan, Doddaballapur main road, Yelahanka New Town, Bangalore – 560064 for the work of *Providing and laying 150 mm dia DI Pipeline from Govindapura main road to Shampura main road by crossing the Railway track to provide the water supply to Gandhinagar and surrounding areas coming under Manorayanapalya Service Station of AEENE-3 Sub Division* from registered Agencies of appropriate class as indicated against each work of WSSB/KUWSDB/KPWD, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT/GST registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the tender shall be uploaded in the website. Tenders will be opened on the date and time mentioned in ITT clause 5 and evaluated. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.


The Eligibility criterion for the above works is as follows:

- The tender is based on Single Cover System
- Contractors should have Civil contractor registration in BWSSB or KPWD / KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- Assessed Available tender capacity (A*N*2.5-B).
- The form of tender as per the proforma available in KW-1 should be duly filled and uploaded in the tender wizard as a part of tender document which is mandatory.
- Refer Annexure (A) enclosed along for jurisdictions of the courts and safety measures to be taken while executing the works as per letter No.BWSSB/EIC/CE(P)/0027/16-17 dt:10.04.2017.
- Applications / requisitions from joint venture Firms are not acceptable.
