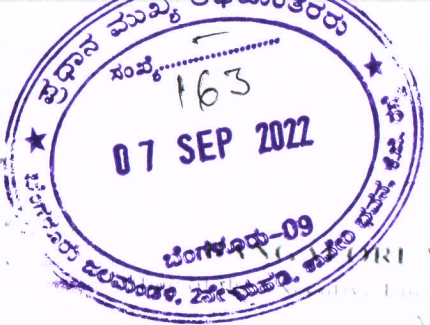

For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM ITEMWAR TENDER** is invited through e-procurement process with tender procedure in line with Rule 28 of the KPPP Act by the Executive Engineer, Water Supply and Sanitary Division (North West 2), 1st floor, Suvarna Bhavan, Margosa Road, 18<sup>th</sup> cross Malleshwaram, Bangalore-560055 for the following work from registered Agencies of appropriate class as indicated against each work of BWSSB/KUWSDB/KPWD, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid GST registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the **Earnest Money Deposit only through e-procurement portal** only using any of the four modes.

- (1) Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

**The Eligibility criterion for the above works allotted for General category is as follows:**

- Contractors should have registration in BWSSB or KPWD/KUWSDB, etc  
Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- Form of tender is mandatory to upload in e-procurement portal.
- Assessed available tender capacity  $(A*N*2.5 B)$  should be greater than amount put to tender.
- The tenderer should have in the last 5 years period achieved in at least two financial years an average annual financial turnover of rupees not less than the estimated cost. (Profit and loss account, Balance sheet certified/Audited by chartered accountant).
- The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the work.
- The rate are based on CSR & is Exclusive of GST which will be paid partly.
- The successful bidder would be required to give performance bank guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled India Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.

**Eligibility criterion for the above works allotted SC/ST category**


- Contractors should have registration in BWSSB or KPWD/KUWSDB, etc  
Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- Form of tender is mandatory to upload in e-procurement portal.
- Assessed available tender capacity  $(A*N*5-B)$  should be greater than amount put to tender.
- Caste certificate should be uploaded in the e-procurement portal issued from the concerned Authority for authentication at the time of bidding.

- Security Deposit for an amount equivalent to 5% of the contract price shall be deducted every running bill. However, in case of final bill the entire security deposit will be deducted from the bill.
- If in two attempts of tender bidding process, Bidders belonging to Scheduled castes and Scheduled Tribes participate is not Qualified under the rule, then these works shall be tendered as open category where all eligible bidders of General or Scheduled castes or Schedules tribes category can participate.
- The tenderer should have in the last 5 years period achieved in at least one financial years an average turnover of not less than estimated cost of the respective works (Profit & loss account, Balance sheet certified Audited by Chartered accountant)
- The tenderer should have satisfactorily completed one similar work to an extent of 25% of the cost of the respective works.
- If Contractor is the firm, then all the partners or members of the firm shall belong to the Schedule castes or Schedule Tribes as the case may be.
- The contractor belonging to the Schedule Castes of Schedule Tribes shall be domicile of the state of Karnataka for more than 10 Years.

6. The tender is based on Single Cover System. Contractors should have registration in BWSSB or KPWD/KUWSDB, etc as per KTPP act. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
7. The Form of tender as per KW-2 should be uploaded during bidding for the tender.
8. The third party inspection will be carried for the work and the third party will be nominated by BWSSB.
9. Applications / requisitions from joint venture Firms are not acceptable.


