For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWAR TENDER/ Short Tender** is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, South2 Division 11th main, 35th cross, 4th T block, Jayanagar, Bangalore-560041 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (National Electronic fund transfer) (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

- Contractors should have registration in BWSSB or KPWD/KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- The tenderer Should have in the last 5 years period achieved in atleast two financial years an average annual financial turnover of rupees not less than, **22.79 lakhs**(profit and loss account, Balance sheet certified, Audited by Chartered Accountant are mandatory)
- The Tenderer should have satisfactorily completed one similar work to an extent **Rs. 11.39 Lakhs**
- Assessed available tender capacity = (A*N*2.5 - B) should be greater than the amount put to tender.

Where,

A = Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

N = Number of years


B = Value of on-going works

The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security **deposit for unbalanced bid amount** from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.


