For and on behalf of the Bangalore Water Supply and Sewerage Board, SHORT TERM TENDER's are invited through e-procurement process with tender procedure in line with Rule-28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-East)-1, 10th main, 1st cross, Indiranagara, 2nd stage, Bangalore-560038 for the following work from registered Agencies of appropriate class as indicated against each work of BWSSB / KUWSDB / KPWD etc., who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The tenderers are required to pay the Earnest Money Deposit only through eprocurement portal only using any of the four modes.

- 1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-procurement.

The Eligibility criterion for the above works is as follows:

- The tender is based on Single Cover as shown in the above table.
- Contractors should have registration in BWSSB or KPWD/KUWSDB, etc as per KTPP act. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.

The tenderer should have in last 5 years period achieved in atleast two financial year an average annual financial turnover of rupees not less than the estimated cost (amount put to tender) ie., Rs.43.03 lakhs and Rs.20.63 lakhs (Profit & Loss account, Balance Sheet should certified / audited by Chartered Account) respectively.

- The tenderer should have satisfactory completed one similar work to an extent of 50% of the cost of the work ie., Rs.21.51 lakhs (providing and laying of 300mm dia MS pipe line) (50% of amount put to tender) and Rs.10.31 lakhs (providing and laying of 300mm dia RCC NP3 class pipe) (50% of amount put to tender) respectively.
- For Other category Assessed available tender capacity should be (A*N*2.5)-B are greater than the amount put to tender respectively, where,

A= Maximum value of Civil Engineering works executed in any one year during the last five years taking into account the completed as well as works in progress **N =** Number of years

 \mathbf{B} = Value of on-going works.

- The Form of Tender is Mandatory to upload in e-procurement portal.
- Applications / requisitions from joint venture Firms are not acceptable.
- Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

- 7. Within 20 Days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a Security deposit in any of the forms given below. For an amount equivalent to 5% of the contract price plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT & clause 44 of the conditions of contract for all works from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified.
