

For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM ITEMWAR TENDER** is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (West)-1, RPC Layout, Vijaynagar 2<sup>nd</sup> stage, Bangalore-560040 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the **Earnest Money Deposit only through e-procurement portal** only using any of the four modes.

1. (1)Credit Card (Online Payment)(2) Direct Debit Using Internet Banking (Online Payment)(3) Remittance at the Bank Counter - Challan (Offline Payment)(4) NEFT (Offline payment). - The tenderer should have in last 5 years period achieved in atleast two financial year an average annual financial turnover of rupees not less than the amount put to tender (inclusive of GST) **ie., Rs.20.43 lakhs** (Profit & Loss account, Balance Sheet should certified / audited by Chartered Account).
- The tenderer should have satisfactory completed one similar work to an extent of 50% of the cost of the work(inclusive of GST) **ie., Rs.10.21 lakhs**
