The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

- The Tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the respective works.(inclusive of GST) i.e.,Rs.36.80 Lakhs.
