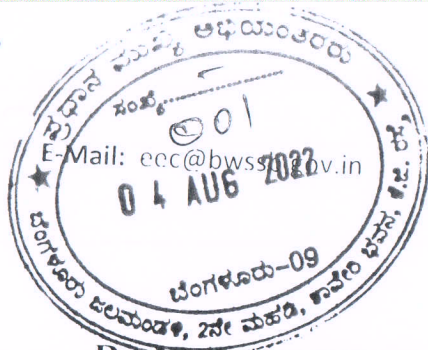

For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWISE TENDER** is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water supply and sanitary Division (Central), High Grounds, Miller Road Bangalore – 560 052, for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

- (1)Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the tender shall be uploaded in the website. Tenders will be opened on the date and time mentioned in ITT clause 5 and evaluated. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.

The Eligibility criterion for the above works is as follows:

- The tender is based on Single Cover System
- Contactors should have Civil Contractor registration in BWSSB or KPWD/KUWSDB etc., Those who does not have BWSSB registration can also participate in the tender provided they should get registered in Board in case the tender is awarded before the issue of Work Order.
- The tenderer should have in the last 5 years period achieved in at least two financial years an average annual financial turnover of rupees not less than the estimated cost **i.e, Rs. 23.08 Lakhs.** (Profit and loss account, Balance sheet certified/Audited by chartered accountant).
- Assessed Available Tender Capacity (A*N*2.5-B).
- Form of tender is mandatory to upload in e-procurement portal.
- The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the work i.e. **Rs.11.54 Lakhs.**
- The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- Applications / requisitions from joint venture Firms are not acceptable.
- The condition put forth as per KW-2 of KTPP Act should be followed read with amendments vide G.O.No.FD4PCL.2008 Bangalore dt: 14.10.2008.

- Note: Road cutting machine should be used mandatorily for cutting the approved width of road while executing the work as per circular No. BWSSB/CH/CAOs/CHI/138/19-20 dt:4.9.2019
- Refer Annexure (A) enclosed along for jurisdiction of the courts and safety measures to be taken while executing the works as per letter No.BWSSB/EIC/CE(P)/0027/16-17 dt:10.04.2017 and is hereby informed to include the same in the contract agreement.
- Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

The attention of the bidders is drawn to clause 22 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
