- Third party will be nominated by BWSSB.
- The successful bidder would be required to give performance bank guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized/Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- Refer Annexure (A) enclosed along for jurisdiction of the courts and safety measures to be taken while executing the works as per letter No.BWSSB/EIC/CE(P)/0027/2016-17 Dt:10.04.2017 & further hereby informed to include the same in the contract agreement.
- The rates quoted in the tender offer shall be by considering the benefits of concession rate of Central Sales Tax (for all interstate

procurement of materials only) as per section *(1) of the CST Act, 1956. Necessary Form C will be issued by Board. After implementation of GST if this clause is removed then bidder consider to the latest amendment.

- The rates quoted should be inclusive of Third party inspection charges and applicable taxes that will be recovered from the bills. Third party will be nominated by BWSSB.
- Each tenderer should further demonstrate (a) availability by owning at least 50% of the required / specified key and critical equipment for this work and (b) the remaining 50% can be deployed on lease/hire basis for all works provided, the relevant documents (commitment agreements etc) for availability for this work are to be furnished especially for the Crane.
- The successful bidder would be required to give performance **bank guarantee of** 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
