On behalf of Bangalore Water Supply and Sewerage Board, The Chief Engineer (Design) invites proposals Work of providing Consultancy Services for the detailed study and preparation of Detailed Project Report (DPR) for Adequacy check of Sewer System in K-100 & K-200 Catchment of Koramangala and Tavarekere Valley and more details on the services are provided in the Terms of Reference.

- 2. Tender documents may be downloaded through e-Procurement Portal www.eproc.karnataka.gov.in website only from 05.03.2022 to 14.03.2022. Interested Service Providers may obtain further information by accessing the same website. Tenders must be accompanied by Earnest Money Deposit specified for the work in the Table below. EMD will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 60 days beyond the validity of the tender.
- 3. The interested Consultancy firms may obtain any details about the RFP through the office from address given below up to 16.12.2021 on all working days between 10.00 hrs and 17:00 hrs. The complete RFP document is only available on E -procurement portal of Government of Karnataka (GoK).
- 4. For submission, evaluation and selection of Consultant, the Proposal should be submitted in two parts. The two parts of the proposal are (i) Part 1: Technical Proposal comprising of Table 1&2 of the APPENDIX-1 and (ii) Part 2: Financial Proposal (to be submitted online through E-Procurement website).
- 5. Part 1 of the proposal would be opened first and evaluated. Only the firms qualifying in Technical Proposal as mentioned in RFP would be considered for further evaluation. The financial proposal of only those firms, who score minimum qualifying marks in Technical Proposal as mentioned in the Terms of Reference would be opened and evaluated. The final selection of the firm would be based on quality and cost based selection (QCBS) the combined score of technical and financial proposal.
- 6. The total time period for the assignment will be as explained in the Terms of Reference.
