The Chief Engineer, (Kaveri), Bangalore Water Supply and Sewerage Board invites tenders from eligible tenderers, for the work of supply, fabrication and laying of 1200mm dia, 900mm dia and 700mm dia Mild Steel water supply pipeline from Sarakki, in lieu of CWSS Stage-I Cast Iron pipeline(3rd Call). Two Cover Tender procedure as per Rule 28 of the KTPP Act shall be followed. The Tenderers are required to pay the Earnest Money Deposit through e-procurement portal only using any of the four modes.
 - a. Credit Card (Online Payment)
 - b. Direct Debit Using Internet Banking (Online Payment)
 - c. Remittance at the Bank Counter - Challan (Offline Payment)
 - d. NEFT (Offline payment).

The Earnest Money Deposit of unsuccessful Tenderers will be returned within 30 days of the end of the tender validity period specified in Sub-Clause 12.1. The Earnest Money Deposit of the successful Tenderer will be discharged when the Tenderer has signed the Agreement and furnished the required Performance Security. The details regarding the capability to undertake the tender (as detailed in Table -A below and Section -2 clause 3 of ITT) and the price schedule shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT Section- 2 Clause -19 and evaluated. The price schedule of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Section -2 Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
