- Contractors should have Electrical Contractor license in CEIG Karnataka.
- Assessed available tender capacity = (A*N*2.5 B) should be greater than amount put to tender.

Liquid assets or availability of credit facilities of not less than Rs 21.37 L/- Credit line/letter of credit /certificate from banks for meeting the fund requirement etc.

- Form of tender is mandatory to upload in e-procurement portal.
- Satisfactorily completed a prime contractor at least one similar work such as Supply Frection and commissioning of Pumping Machinery and other Allied works of value not less than 35.61 Lakhs (In any one year during last 5 Years).

Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
- 8. Other details can be seen in the tender documents.
- 9. Bidders shall visit the site before quoting the tender.
- 10. The works to be executed in accordance with the contract documents and to carry out all the works as per the guidelines. Any lapses in following the safety guidelines, the contractor/agency/firm will be held solely responsible.
- 11. The rates quoted should be inclusive of Third Party inspection charges & applicable taxes that will be recovered from the bills. Third party will be nominated by BWSSB.
- 12. Two officers are deputed for the site inspection for materials from the department. And the cost towards the travelling and other expenses are going to be borne by the tenderer for site inspection of the materials.
- 13. The contractor should provide safety equipments to the workers at the time of execution of the work. If any objection from public or any organization at the time of execution of the work in respect of not wearing the safety equipments, the contractor will be held responsible for the same.
- 14. Even though the tenderers meet the above criteria, they are subject to be disqualified if they have:
 - Made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
 - Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.; and/or
 - participated in the previous Tender for the same work and had quoted unreasonably high tender prices and could not furnish rational justification.
