- The Tender is based on Single Cover System.
- Contractors should have registration in BWSSB or KPWD/KUWSDB, etc. Those who does
  not have BWSSB registration can also participate in the tender provided they should get
  registered in the Board in case the tender is awarded before the issue of Work Order.
- The Tenderer should have a minimum average annual financial turnover of **Rs.44.76 lakhs** in at least two years in the last five years (2017-18 to 2021-22).
- The tenderer should have satisfactorily completed at least one similar work such as construction of the SSM compound wall to an extent of Rs.22.38 lakhs in the last five years. (i.e. 2017-18 to 2021-22)
- The Form of tender as per the proforma available and Bid Capacity (A\*N\*2.5 B) should be greater than Rs.44,75,652/- (amount put to tender) in KW-2 should be duly filled and uploaded in the tender wizard as a part of tender document which is mandatory.
