For and on behalf of the Bangalore Water Supply and Sewerage Board, PERCENTAGE/ITEMWAR TENDER is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South West)-2, Shimsa Bhavana, Jayanagar, Bangalore-560078 for the following work from registered Agencies of appropriate class as indicated against each work of BWSSB/KUWSDB/KPWD, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement, portal only using any of the four modes.

- 1. (1) Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.

The Eligibility criterion for the above works is as follows:

The tender is based on Two Cover System

- Contractors should have be a Civil contractor and have contractor registration in BWSSB or KPWD/KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- 2. The Tenderer Should have in the last 5 years period achieved in at least two financial years an average annual financial turnover of rupees not less than the estimated cost i.e., Rs. 56.25 lakhs (Profit and Loss Account, Balance Sheet certified, Audited by Chartered Accountant are mandatory).
- 3. The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the work Rs. 28.13 lakhs.
- 4. Assessed available tender capacity = (A*N*2.5 B) should be greater than the amount put to tender.
 - A = Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

N = Numbers of years

B = Value of on going works

The contractor should have executed in any one year for a continuous period of 12months usually 80% of the annual requirement such as providing and laying of 200mm dia D.I pipe-890 Rmt.

200min decided assets or availability of credit facilities should be 30% of the amount of contract
