Your request to withdraw the letter No.BWSSB/EIC/CE(M)/ 1139 /2016-17 dt:29.4.2016 & also to pay necessary amount of Rs.10,71,74,570/- as proportionate individual share to BWSSB, was examined in detail.

As per your request, BWSSB agrees to withdraw the condition that the residents of AECS Layout need not produce NOC from the Society while seeking water supply & UGD connection from Board as mentioned in the letter No.BWSSB/EIC/CE(M)/ 1139 /2016-17 dt: 29.4.2016, subject to the condition that BWSSB will take over the AECS Layout at Kudlu only after entire amount of Rs.10,71,74,570/- is received by BWSSB. For the other details as mentioned in your letter dt: 29.4.2016, the decision is as follows:

1	Permission for direct payment of Cauvery water connection charges to BWSSB, through DD or Bank Challan to the residents of ACES Layout out Singha Sandra.	Permission for direct payment for Cauvery water connection BWSSB through DD or challan can be given, subject to the condition that a) only after the entire amount of Rs.10,71,74,570/- is remitted to BWSSB. b) After this the individual owners should pay the prorata & GBWASP charges as per the existing rules of BWSSB
2	With drawl of BWSSB letter No.1139 dt" 29.4.2016, addressed to the president of AEHBS Ltd., so that residents of AECS Layout need not get NOC from Society.	BWSSB agrees to withdraw the condition that the residents of AECS Layout need not produce NOC from the Society while seeking water supply & UGD connection from Board as mentioned in the letter No.BWSSB/EIC/ 1139 dt: 29.4.2016, subject to the above conditions as mentioned para (1).
3	Consider, Govt. of Karnataka order dt: 25.12.2003, where, a sum of Rs.658.64 Crores was sanctioned to seven zones including Bommanahalli, thus, this zone must have got Rs.94.00 crores for this type of work. Hence, we again request you to provide Cauvery water to our area, as per the existing charges only, and reduce the infrastructure cost proportionately.	Providing UGD facilities to former 7 CMCs & 1 TMC was taken up with the financial assistance of World Bank and JnNURM under KMRP has been completed, hence it is not feasible to consider the request.
4	Request proportional distribution of cost of the water supply project, both for the residents and also the private constructions in the same area, since all will be using the same backbone connectivity of BWSSB.	The amount of Rs.10,71,74,570/- is assessed considering only block-A of AECS Layout and hence distribution this amount to other private constructions in the same area is not feasible
5	Request assign an AEE for the spot survey and issue demand notice to the residents for quick payment of the fee to BWSSB and pass instructions to EIC for completion of the project within reasonable time and not exceeding six to nine months from the date of payment to ease the water problems of the residents.	Residents Welfare Association has to take responsibility to collect the deposits from the individual plot owners and collectively deposit to BWSSB for taking further action.
