THE BANGALORE WATER SUPPLY (AMENDMENT) REGULATIONS, 2018

In exercise of powers conferred by Sections 61 and 88 of Bangalore Water Supply and Sewerage Act, 1964 (Karnataka Act 36 of 1964) and all other powers enabling it in this behalf and with previous approval of the State Government vide Government Order No. UDD 4 MNI 2018 Bengaluru dated 02-02-2018, the Bangalore Water Supply and Sewerage Board hereby makes the following regulations further to amend the Bangalore Water Supply Regulations, 1965, the draft of the said Regulations having been previously published as required by sub-section (2) of Section 88 of Bangalore Water Supply and Sewerage Act, 1964, vide Notification No. BWSSB/C/CAO-S/4732/2017-18 dated 03.02.2018 in the Part IVA of Karnataka Gazette dated 03.02.2018 namely,-

1. Title and Commencement.- [1] These regulations may be called the Bangalore Water Supply [Amendment] Regulations, 2018.

[2] They shall come into force from the date of their publication in the official Gazette.

2. Amendment of Regulation 7.- After regulation 7.4 of the Bangalore Water Supply Regulations, 1965 (hereinafter referred to as the said regulations) the following shall be inserted, namely:-

“7.5 Wherever applicable the applicant shall comply the provisions of regulation 4A of the Bangalore Sewerage Regulations, 1974.”

3. Amendment of regulation 36:- In regulation 36 of the said regulations under the heading “**I. Water Supplied**” in clause (d), after the words “residential purposes” the words “or to schools and educational institutions established or maintained by the State Government or Central Government and the Bruhat Bengaluru Mahanagara Palike” shall be inserted.
